The Last Great Ape Organization – LAGA February 2020 Report



Highlights

- A trafficker arrested in Bandjoun, West Region, with 5 large leopard skins
- A new Head of the Media Department was appointed by the Director.
- The Deputy Director attended an Interpol meeting aimed at setting state-level priorities and needs for effective operations.
- The LAGA family travelled to Batie in the West Region to participate at funeral activities of former investigator who passed away after a protracted illness.

General

This month was marked by the arrest of a traffickers with leopard skins.

The trafficker is experienced in leopard skin trafficking and ran a network with traffickers spanning some major towns in the region. He equally travelled to the East Region where he bought one of the skins he was attempting to sell. He owns a shop at one of the main markets in Bafoussam, the capital of the West Region.

The Deputy Director participated at a meeting organized by Interpol officials that was aimed at developing priorities and needs for future operations within the West and Central African sub region.

On the invitation of the Belgian Ambassador, he participated at the meeting with top gendarmerie officials to discuss a wildlife case with connections to the gendarmerie.

The LAGA family travelled to Batie in the West Region to participate at funerals activities of former investigator who passed away following a protracted illness.

Investigations

- **16 investigation missions** were carried out in **5 Regions** out of the 10 Regions of Cameroon viz: Centre, East, South, Littoral and West Regions.
- Credible information from an informant in Bafoussam led to the arrest of 1 trafficker with 5 leopard skins in Bandjoun.

Operation

An operation carried out this month with MINFOF arresting a trafficker with 5 leopard skins.

24/2/2020 – a trafficker arrested in Bandjoun, West Region with 5 leopard skins. The trafficker belongs to a network of leopard skins trafficking that is rife in the region and members of the network are located in different towns of the region. The trafficker is a businessman in one of Bafoussam's main markets where he owns a shop. He equally passes as a traditional herbalist.

Legal

• LAGA Legal Department carried out **10 missions** out of Yaounde-Centre Region: 2 in Mfou (Centre), 1 in Ebolowa (South), 1 in Snagmelima (South), 1 in Kribi (South), 2 in Douala (Littoral), 2 in Bandjoun (West) and 1 in Bafoussam (West).

- There are **7 traffickers behind bars this month:** 3 in East region, 1 in South region and 3 in Littoral region.
- **26 cases** were followed up by the Legal Department this month.
- 24 cases were scheduled in court this month.
- 9 traffickers were convicted this month.
 - 20/02/2020: The Ekounou Court of First Instance found the accused LOKO BASSILIKIN, FOGANG FOKOUA Bruno, NKOUGA Valère, OUSMANOU Baba and KENNE Emmanuel guilty and sentenced them to 200,000 FCFA each as fines, 46,000 FCFA each as court fees and 400,000 FCFA jointly as damages.

They were arrested in Yaounde on the 05/09/2019 for the illegal possession of 2 elephant tusks.

- **28/02/2020:** The West Appeal Court, in the case **of MINFOF against MELAT Blaise, NFONGOCK Didier, NYAMPE Charles and ATOKI Suzanne** upheld the decision of the Court of First Instance of Dschang. They were sentenced to pay 100,000 FCFA each as fines and 38,000 each as court fees

They were arrested in Santchou on the 04/05/2018 for the illegal possession of an elephant tusk, a turtle shell and pangolin scales.

Media

- A new head of the Media Department was appointed. Anna Egbe Etaka takes over from the Deputy Director who has held the position for over 9 years.
- **19 media pieces** were produced and pushed through to written press, television, internet and the radio, including; 6 written press materials (4 in English language and 2 in French Language), 1 TV production (in French), 1 internet publication (in French) and 11 radio news flashes (4 in French and 7 in English).
- Interviewee: The LAGA Deputy Director
- Subjects focused on wildlife law enforcement including: The celebration of the World Pangolin Day, and the Bandjoun arrest of a trafficker with 5 leopard skins.
- 11 media pieces in English language and 8 in French language making a percentage of 57.8% in English and 42.1% in French.

External Relations and Policy

- The Deputy Director did a short talk on LAGA's activities and its collaboration with Interpol at a three-day Interpol meeting that brought together Interpol, Wildlife and Customs officials who focused on finding state-level priorities and needs for an upcoming Interpol operation against wildlife trafficking that shall be carried out in the various member countries within the West and Central African sub regions.
- On the invitation of the Belgian Ambassador, the Deputy Director participated at a meeting
 at the Secretariat of Defence in Charge of the Gendarmerie that brought together 5 top
 gendarmerie officials including the Central Deputy Director of Coordination and a technical
 adviser. The meeting was focused on discussing some wildlife cases at the courts with links
 to the gendarmerie.
- A legal adviser participated at a workshop organized by ZSL that aimed at training ecoguards
 of the TRIDOM on the protection of African grey parrots. She did two presentations, one on
 law enforcement activities carried out by LAGA against parrot traffickers and the other on
 the calculation of damages to be awarded MINFOF in wildlife cases.
- Activities were carried out by several conservation organisations including LAGA, working under the framework of the Cameroon Pangolin Working Group to mark the World Pangolin Day and included a press conference facilitated by the Deputy Director.
- The LAGA team joined other conservation organisations to carry out activities marking the World Pangolin Day. These included the sharing of handouts, a press conference that was facilitated by the Deputy Director among many others.

Management

- The LAGA team travelled to Batie, West Region to participate at funeral activities of their former colleague and member, Ma Mado who died after a long illness.
- Preparations were made for the trip of the new media head who is expected to attend the UN celebrations of the World Wildlife Day.
- An Italian movie crew returned to the country to continue filming with the investigation and legal departments for the production of a movie depicting efforts may by the Cameroon government in fighting the illegal pangolins scales trade.

Presentation: Control and Co-ordination in an organization

The presentation was about how to control and coordinate an organization, in other to achieve the organizational objectives. The presenter mentions the fact that control and coordination are crucial managerial functions for every entrepreneur, to make sure that their goals are achieved within a given time. She started by defining the main concept, and explains how do these two functions are often confused with each other and sometimes seem to mean the same thing. Discussion focused on the difference between control and coordination, and how to effectively put these functions in place.
