# The Last Great Ape Organization – LAGA July 2022 Report



## **Highlights**

## **Investigations**

- **16 investigation missions** out in **6 Regions** out of 10 of Cameroon including Littoral, West, Centre, Adamawa, South and East Regions.
- The Head of the Investigation Department held a meeting with the Divisional Officer, the Chief of Wildlife Control Post, the Gendarmerie Brigade Commander, and the Commissioner for the Special Police Station in Ayos to strengthen collaboration.
- He also met the newly installed Kye ossi. Chief of Wildlife Control Post to strengthen collaboration and information sharing.

• This month no operations took place, but the department brainstormed and came out with new strategies to ensure arrests next month.

## Legal

- LAGA Legal Department carried out **7 missions** out of Yaounde Centre Region: 1 in Ebolowa (South), 1 in Sangmelima (South), 2 in Douala (Littoral), 1 in Akonolinga (Centre), 2 in Ngoumou (Centre).
- There are **15 traffickers behind bars this month:** 3 in East Region, 2 in South Region, 2 in Centre, 2 in Littoral Region and 6 in West Region.
- **36 cases** were followed up by the Legal Department this month.
- 31 cases were scheduled in court this month.
- 1 trafficker was convicted this month.
- **Prosecutions**: There was 2 court ruling this month.
  - 04/07/2022: The Douala Bonassama Court of First Instance found the accused NUMVI Christopher guilty and sentenced him to 3 months in prison and to pay 100,000 FCFA as fine and 2,000,000 FCFA as damages.

He was arrested in Douala - Bonaberie on the 08/04/2022 for the illegal possession of one mandrill.

05/07/2022: The Ngoumou Court of First Instance found the accused OTTOU ATANGANA Moïse not guilty and acquitted him.

He was arrested in Yaounde - Bandouma on the 28/03/2022 for the illegal possession of two chimpanzees.

- Appeal: An appeal has been filed this month in the case of OTTOU ATANGANA Moïse at the Centre Court of Appeal.

## **Media**

- **20 media pieces** were produced and pushed to the media including: written press, radio, and internet. That is 11 written press (8 in French language and 3 in English language), 5 radio news flashes (3 in English language, 2 in French language), and 4 internet publications (3 in French and 1 in English).
- Giving a total of 13 media pieces produced in the French language and 7 in the English making 65% in English, and 35% French.
- Subjects focused on wildlife law enforcement including: the court hearing of two traffickers arrested with a mandrill in Douala and the court hearing of 3 traffickers at the Court of First Instance of Ekounou for the illegal possession of 386kg of pangolin scales.


