# The Last Great Ape Organization – LAGA October 2020 Report



# Highlights

- LAGA provided technical assistance to customs and wildlife officials following the arrest of a trafficker in Ambam with 118 ivory tusks. The tusks were hidden in a secret built-in compartment in a truck he was driving from the south to Yaounde The team carried out follow up investigations, exposing international links and equally followed up the legal and prosecution procedure.
- The Deputy Director attended the ceremony presided over by the Minister of Forestry and Wildlife that saw the presentation of the National Anti-Poaching and Wildlife Crime Strategy document.
- The Deputy Director facilitated a workshop that focused on contributing to the deepening and harmonization of the understanding of institutional actors of the causes and consequences of agro-pastoral conflicts.

## **General**

Following the arrest of a big time ivory trafficker with 118 ivory tusks in Ambam by the customs, and under the framework of the the Memorandum of Understanding with customs, LAGA provided technical assistance to customs and wildlife officials in relation to the legal procedure in prosecuting the wildlife law offender. The team carried out further investigations that show some of the ivory came from Gabonese government stockpiles and from operations carried out by the Gabonese government assisted by the Gabonese EAGLE project named Conservation Justice. The trafficker is connected to a network stretching from countries such as Gabon, Congo, Equatorial Guinea to Nigeria.

The Deputy Director attended the ceremony presided over by the Minister of Forestry and Wildlife that saw the presentation of the National Anti-Poaching and Wildlife Crime Strategy document and a copy of the document was given to LAGA that participated in the elaboration of the strategy during workshops held for that purpose.

The Deputy Director facilitated a workshop that focused on contributing to the deepening and harmonization of the understanding of institutional actors of the causes and consequences of agropastoral conflicts. The workshop, organized by human rights group RECODH, brought together state actors and NGOs working in the domain.

He equally was a guest on prime time CRTV News programme Twilight to talk on the recent seizure of 118 ivory tusks in the south of the country, the causes and consequences of ivory trafficking and elephant extinction.

# **Investigations**

• **18 investigation missions** were carried out in **5 Regions** out of the 10 Regions of Cameroon including the Centre, East, Littoral, South and West Regions.

#### Legal

- LAGA Legal Department carried out **4 missions** out of Yaounde Centre Region: 1 in Douala (Littoral), 1 in Foumbot (West), 1 in Ebolowa (South) and 1 Ambam (South).
- There are **15 traffickers behind bars this month:** 5 in East region, 2 in Centre region, 1 in Littoral region, 1 in South region and 6 in West region.
- **31 cases** were followed up by the Legal Department this month.
- 27 cases were scheduled in court this month.
- **No trafficker** was convicted this month.
- LAGA provided technical assistance to customs and wildlife officials following the arrest of a trafficker in Ambam with 118 ivory tusks hidden in a secret built-in compartment in a truck he was driving from Ambam to Yaounde. The ivory was trafficked from Gabon and Equatorial Guinea and was heading to the Yaounde for an illegal transaction. He is considered to be one of the main traffickers in a ring that deals in huge quantities of ivory in the sub region and right to Nigeria. The team carried out further investigations into the case exposing international links and the fact that some of the tusks were from Gabonese government stockpiles and seized from operations carried out in collaboration with Conservation Justice, the EAGLE member based in Gabon.

# <u>Media</u>

- **30 media pieces** were produced and pushed through to written press, internet and radio including: 15 written press materials (8 in French and 7 in English), 8 internet publications (6 in French and 2 in English), and 6 radio news flashes (3 in French and 3 in English), and 1 TV production in English
- Interviewee: The Director and the Deputy Director of LAGA
- Subjects focused this month on wildlife law enforcement including: the arrest of two people with 3 African grey parrots and 6 Rose-ringed parakeets in Yaounde, and a man arrested with 626kg of ivory in Ambam.
- 17 media pieces in French language and 13 in English language making a percentage of 56.66% in French and 43.33% in English.

#### **External Relations and Policy**

- The Deputy Director attended the ceremony presided over by the Minister of Forestry and Wildlife that saw the presentation of the National Anti-Poaching and Wildlife Crime Strategy document and a copy of the document was given to LAGA that participated in the elaboration of the strategy.
- The Deputy Director facilitated a workshop that focused on contributing to the deepening and harmonization of the understanding of institutional actors of the causes and consequences of agro-pastoral conflicts. The workshop, organized by human rights group Recodh brought together state actors and NGOs working in the domain.

- He attended a workshop organized by TRAFFIC that focused on presenting the preliminary analysis of the impact of training workshops organized and the tools developed by TRAFFIC and WWF to combat wildlife crime in Cameroon between 2015 and 2019.
- The head of department held a meeting with the Ambam state counsel to discuss a case at his chambers. He held another meeting, accompanied by a legal advisor, with the Yaounde centre administratif state counsel to discuss matters forwarded to him. Another legal advisor held a meeting with the attorney general of the Littoral Region to discuss a case forwarded to his chambers and the legal advisor would later hold another meeting with the Douala-Ndokoti state counsel for the same purpose.

## <u>Management</u>

- The entire LAGA team took time off from work to visit the seaside resort town of Kribi for relaxation and team building activities and returned ready to contribute more to ensuring successful operations before the year runs out.
- An evaluation meeting was held to take stock of how things have evolved over the Covid-19 period, examining our efforts, results and plans to make a final dash for more results before the year ends. There was a review of measures taken to ensuring comprehensive protection of everyone during the trying period of the pandemic.
