# The Last Great Ape Organization - LAGA September 2008 Report



## **Highlights**

- A LAGA family member effectively kicks off RALF activities in the Republic of Congo.
- **6 operations against 6 dealers** in the replication of LAGA's experience in the Republic of Congo.

### General

This month was marked by a special focus on replicating LAGA's model of effective wildlife law enforcement in the Republic of Congo.

LAGA's vision of replicating its model to other countries in the sub-region has already started to be realized. In April the transfer of experience was concretised in tangible results with a successful operation when a renowned international ivory dealer was arrested. A LAGA family member arrived the Republic of Congo to coordinate the activities of RALF and charged with transferring Cameroon government's globally acclaimed wildlife law enforcement experience to Congolese wildlife law enforcement authorities. This followed a special mission carried out by the Director of LAGA in April to the Republic of Congo. The mission was very successful and was geared at igniting law enforcement through precedence and creating a structure to sustain effective law enforcement at the request of the government. It was carried out at 3 levels:

- 1. Political
- 2. Structural
- 3. Operational

The newly arrived RALF Coordinator following this model has held meetings with Ministry officials, Judiciary, Forces of Law and Order, Embassies, International bodies etc. At the operational level, **6 operations** have so far been carried out with **7 dealers arrested**. In one of the operations, the dealer had a **gorilla hand**, products and parts of other endangered wildlife species. In another operation a well-known ivory trafficker of **Senegalese nationality** was arrested trying to illegally trade in 45 pieces of ivory. He has been in the republic of Congo since 1982 and was arrested in the Plateau market in Brazzaville known to be one of the main ivory supply points in **West Africa** with **Chinese** as the main customers.

Also, The Director of LAGA held a meeting with the Minister of Forestry and Wildlife to discuss about the signing of the Memorandum of Understanding between LAGA and MINFOF.

#### **Investigations**

- 23 investigations of varying lengths were carried out in 5 Provinces South West, West, Littoral, East and Center.
- Recruitment of field investigators and field test continued. The process will continue until competent investigators are recruited. Before the recruitment process is finished, the investigation unit is in low capacity and sending candidates to "test missions" results in low return rate of produced operations.

## **Operations**

No operations succeeded in this month due to the problem of "test missions" of new investigators results in low return rate of produced operations.

## **Legal**

- LAGA legal department carried out **11 missions** out of Yaounde Center Province: 2 in Buea (South West), 1 in Limbe (South West), 1 in Mamfe (South West), 1 in Douala (Littoral), 1 in Bertoua (East), 1 in Abong-Mbang (East), 1 in Dschang (West),.
- There are **6 dealers behind bars during this month**: 1 in East Province, 2 in the West Province, 2 in the South West Province, and 1 in the Center province.
- 33 cases were followed up by the Legal Department this month.
- 19 cases are scheduled and being tried in the court this month.

## Media front

- **16 media pieces** were produced and pushed through to radio, TV and written press including: 1 written press material in French, 3 radio talk shows (all in English,), 1 radio news feature (English), 9 radio news flashes (7 in English, 2 in French), 2 TV news features (in English).
- Guests include: Minister of Forestry and Wildlife, LAGA Legal Unit, Assistant Programme Officer for CARPE, Information Officer of US embassy, Head of Media and External Relations of LAGA, Control Brigade Unit MINFOF, Research Officer CEFOR, British High Commissioner to Cameroon, and Barrister Olivia Mah.
- Subjects focused on wildlife law enforcement including: Tania Siyam convicted in USA for trafficking in ivory, Parrot follow up cases in Douala and Congo ivory arrest.
- 12 media pieces in English, 4 in French making a percentage 75% in English and 25% in French.
- Online sensitization still stood at more than 500 visits to the LAGA website in the month of August.

## **External Relations and Policy**

- The Director of LAGA held a meeting with the Minister of Forestry and Wildlife to discuss about the signing of the Memorandum of Understanding between LAGA and MINFOF.
- Meeting held between the Head of Media and External Relations of LAGA, the Consultant of GRASP and Focal point CARPE to discuss negotiations on gorilla agreements scheduled to take place in Rome in November 2008, the year of gorillas which is 2009 and the Congo Basin forest partnership.
- LAGA participated and presented a paper on wildlife law enforcement operations at a
  workshop organised by CCORUD on monitoring the effectiveness of forestry control post in
  implementing the wildlife law for good governance in Cameroon, under the support of
  Cameroon Regional Programme for the Environment and Ministry of Forestry and Wildlife.
- The Head of Media and External Relations met with the British High Commissioner Syd Madicott and discussed about the problems inherent in the revision of the MoU between LAGA and Ministry of Forestry and Wildlife.
- The Director of LAGA held meeting with the Director for the Centre for Environment and Development; discussion was based on fighting corruption in the NGO sector and corruption involving logging companies.
- Meeting was also held with the Secretary of State Minister Delegate in charge of Prisons to discuss on the permission for LAGA to interview convicted wildlife dealers in order to increase professionalism for investigation.

#### Management
