Highlights

- An ape trafficker arrested and a chimpanzee rescued in Ebolowa, South Region
- 2 more traffickers arrested and a mandrill rescued in Ebolowa, South Region.

General

This month was marked by the arrest of 3 traffickers, one for trafficking in live chimpanzee and 2 others for illegal possession of a mandrill.

An ape trafficker arrested, and a baby chimpanzee rescued; 2 more traffickers arrested with a young mandrill in Ebolowa, South Region. The ape trafficker was arrested while attempting to sell the chimpanzee. The animal had been chained and caged alongside a dog in the home of the trafficker. The little female was frail and aggressive and looked like she had suffered from trauma. The trafficker talked about trying to sell the chimp to a governor. The mandrill was spotted in the street by the arresting team. The trafficker was arrested and a second detained at the police station when he showed up after police requested for his presence.

The Deputy Director participated at an event to welcome new embassy officials of the Political and Economic Section of the US Embassy in Yaounde. He held brief discussions with the US Ambassador and the Second Secretary of the Japanese Embassy in Yaounde. Discussions focused on wildlife law enforcements and the fight against wildlife crime.

Investigations

- **9 investigation missions** were carried out in **4 Regions** out of 10 of Cameroon including the Littoral, Centre, East and South.
- Credible information from a South based informant led to the arrest of a primate trafficker and a live baby chimpanzee rescued in Ebolowa.
- The Head of the Department met the Judicial Police Chief of Ebolowa in a bid to renew working relations and appreciate his efforts in the last operation

An operations carried out this month with MINFOF arresting 3 traffickers.

Legal

- LAGA Legal Department carried out **7 missions** out of Yaounde Centre Region: 1 in Akonolinga (Centre), 1 in Bafia (Centre), 1 in Nanga-Eboko (Centre), 1 in Dschang (West), 1 in Ebolowa and 2 in Douala (Littoral).
- There are **17 traffickers behind bars this month:** 2 in East region,4 in South region, 2 in Centre, 3 in Littoral region and 6 in West region.
- 32 cases were followed up by the Legal Department this month.
- 29 cases were scheduled in court this month.
- 2 traffickers were convicted this month.
- **Prosecutions**: There was a court ruling this month.

08/08/2023: The Dschang Court of First Instance discontinued the procedure against DJOUOTE Hubert following the death of the accused and found the accused FOSSO innocent and not guilty for lack of evidence. On the other hand, the court found the accused BOUNA Jean Valerie and MBE Jean guilty and sentenced them to pay 150,000 FCFA each as fine and 4,587,500 FCFA jointly as damages.

They were arrested in Balessing on the 23/06/2023 for illegal possession of 3 leopard skins and a crocodile skin.

- The Head of Department held a meeting with the State Counsel of Dschang to discuss legal strategies concerning a matter pending before the court
- A legal adviser also met with the State Counsel of Akonolinga to discuss legal strategies concerning a matter pending before the court
- She also met with the State Counsel of Bafia for the same purpose
- A legal adviser held a meeting with the Attorney General of Douala to discuss legal strategies concerning a matter pending before the Appeal Court.
- He held another meeting with the State Counsel of Yaounde Centre Administratif to discuss legal strategies concerning a wildlife case at the court.


