# The Last Great Ape Organization – LAGA December 2018 Report



### **Highlights**

- 5 wildlife traffickers arrested in Abong Mbang in the East Region with over 31kg of pangolin scales.
- Recruitment of volunteers for the position of legal advisers started with several interviews conducted.
- The entire LAGA team went on annual vacation and end of year activities were carried out. Office reopens in January 2019.
- 2 traffickers slammed one-year jail term following their arrest in March with ivory, hunting rifle and military fatigues.

## **General**

This month was marked by the arrest of 5 traffickers with 31kg of pangolin scales

Five people were arrested in connection with the trafficking of 31kg pangolin scales and one the traffickers managed to escape on the pretext of going to the toilets. The person who provided assistance to the fugitive was immediately arrested and all suspects moved to the police station after family members of the traffickers stormed the wildlife office creating chaos and violence while attempting to force the release of the traffickers. It is during the turmoil that one of the traffickers escaped. We are pushing for the arrest of the fugitive once again.

Two traffickers were given a one-year imprisonment term by a court following their arrest in March this year with 4 ivory tusks, military fatigues and a rifle which was used in killing elephants. They were ordered to pay fines and damages of over 10 million CFA Francs.

### **Investigations**

- **15 investigation missions** of varying lengths were carried out in **4 Regions** of Cameroon including Littoral, Centre, South and East Regions.
- Good investigations in Abong Mbang led to the arrest of 5 pangolin scales traffickers in Abong Mbang with 31kg of pangolin scales.

#### **Operation**

One operation carried out this month with MINFOF arresting 5 traffickers.

• 6/12/2018 – 5 traffickers arrested in Abong Mbang, East Region with 31kg of pangolins scales. The pangolin scales were stuffed into rice bags and knacksacks when wildlife officials found them as the traffickers were carrying out the transaction. They are specialized pangolin scale traffickers who connect the big time city dwelling traffickers and the local poachers who collect the scales. They supply the big cities of Yaounde and Douala. Following their arrest family members would arrive the wildlife office creating chaos and violence. One of the traffickers, aided by one of those who arrived, escaped and the facilitator was immediately arrested and all five taken to the police station. The confidence demonstrated by the family members during their attempts at releasing the traffickers is an indication of the weakened authority of the wildlife office in that particular area that is notorious for corruption and weak law enforcement.

### Legal

- LAGA Legal Department carried **5 missions** out of Yaounde-Centre Region: 3 in Douala (Littoral) and 2 in Abong-Mbang (East).
- There are **15 dealers behind bars this month**: 8 in East Region, 6 in South Region and 1 in Littoral Region.

- **28 cases** were followed up by the Legal Department this month.
- 23 cases were scheduled in court this month.
- 10 traffickers were convicted this month.
- **Prosecutions**: There were four court rulings this month.
  - 05/12/2018: The Douala Ndokoti Court of First Instance found the accused KANA DOUANYA HERVE and DIGSIA Timothée guilty as charge and sentenced them to 8 months suspended sentence during 3 years and to pay 100.000 FCFA each as fine and 3.350.000 FCFA jointly as damages.

They were arrested in Douala on the 12/07/2018 for the illegal possession, circulation and commercialization of a live chimpanzee.

13/12/2018: The Ambam Court of First Instance found the accused NKOMO Joseph, AWOUKA Basile and MBO Epse ASSAM Bernadette guilty as charged and sentenced them as follows:

NKOMO Joseph and AWOUKA Basile one (1) year closed imprisonment each, MBO Epse ASSAM Bernadette 6 months suspended sentence during 2 years. They were also sentenced to pay 10.500.000 FCFA jointly as damages.

They were arrested in Meyo-Centre on the 02/03/2018 for the illegal possession, circulation and commercialization of two ivory tusks and killing of an elephant.

28/12/2018: The Douala – Bonanjo Court of First Instance found the accused MAHAMA
 Rabiou guilty as charge and sentenced him to pay 30.475.000 FCFA as damages and
 200.000 FCFA as fine

He was arrested in Douala on the 18/08/2018 for illegal possession of 80 Kg of pangolin scales.

28/12/2018: The Douala – Bonanjo Court of First Instance found the accused Garba Hamadou, Abdoul Karim, Laminou Abbo et Mohamadou Habibou guilty as charged and sentenced them to pay 50.855.000 FCFA jointly as damages and 200.000 FCFA each as fine.

They were arrested in Douala on the 18/08/2018 for illegal possession of 630 Kg of pangolin scales.

An appeal shall be filed against ruling in the case of MAHAMA Rabiou, Garba Hamadou, Abdoul Karim, Laminou Abbo and Mohamadou Habibou in the Littoral Court of Appeal.

## **Media**

- 22 media pieces were produced and push into the various media including the written press, radio and internet during the month ending a successful year with 371 media pieces passed at the various news outlet at the rate of one per day.
- During the month, the following statistics were recorded: 11 written press material (6 in English and 5 in French), 10 radio news flashes (5 in French and 5 in English), and 1 internet LAGA

- publication in French. 11 media pieces were in French and 11 in English making a perfect balance of 50% each
- Subjects focused on wildlife law enforcement including the Douala arrest of 3 persons with 125 tusk and dozens of ivory pieces, and the Abong Mbang arrest of 5 people with pangolin scales.

## **External Relations and Policy**

- The Head of the Legal Department and the Assistant Head of Media participated at a two-day training workshop organized by Forest Law Enforcement Governance (FLEGT) in partnership with FLAG and FODER. The aim of the workshop was to equip participants with the skills that are required to be able to use the new FLEGT watch tool and determine possible areas of application in participants' core activity.
- The Head of the Legal Department held meetings with state counsels in Douala Bonanjo to discuss cases pending in their courts and ongoing investigations.
- Accompanied by a legal adviser, he held a meeting with the state counsel in Abong Mbang shortly before the operation against the pangolin scales traffickers was carried out.
- A second legal adviser equally held a meeting with the Abong Mbang State Counsel to discuss matters pending at his court.

#### Management

- The recruitment process in the legal department move a step further with several interviews conducted.
- Several end of year activities including gift sharing, bonuses award and annual end of lunch were carried out under the stewardship of the management team.

#### **Presentation: Annual Leave**

On the last day of work, the presenter gets in the holiday mood with the rest of the team in discussing annual leave. He explains that it is the worker's right and it is in the interest of the employer and the employee to take annual leaves because studies have proven it to be beneficial for the health of the employee and the organisation benefits in improved performances. He outlines some of the characteristics of annual leave including, it being paid leave, it is a right, it is negotiated, it is regulatory, it is associated with travelling, rest and holidaying etc. Discussions focused on each outlining how they are going to spend their annual leave and advice on ensuring each takes time off, shut out from work and gets some much deserved rest.
