General

This month was marked by the arrest of a trafficker with a young drill.

A primate trafficker arrested and a drill rescued in Yabassi, in the Littoral Region. The very young drill, an endangered primate, stressed and agitated, was tied with a rope in the waist. The trafficker, who works for a city council, transported the cage with the drill on his bike. He was waiting for another supply of a baby primate that was killed when local poachers shot dead its mother.

The Deputy Director participated at the event celebrating the King of England's birthday. He had brief discussions with some diplomats, the Vice President of the Senate and the Director of Customs on wildlife crime.

Recruitment was intensified with two candidates that started their testing and training period at the media and management departments respectively.

- **12 investigation missions** were carried out in **4 Regions** out of 10 of Cameroon including the Littoral, Centre, East and South.
- Good investigation in Yabassi led to the arrest of a primate trafficker with a live drill in Yabassi.

Operation

An operation carried out this month with MINFOF arresting 1 trafficker.

He kept the animal at his residence in a Yabassi. The trafficker, who works for the local city council, transported the cage with the drill on his bike. He was waiting for another supply of a baby primate that was killed when local poachers shot dead its mother.

Legal

• LAGA Legal Department carried out **5 missions** out of Yaounde - Centre Region: 1 in Akonolinga (Centre), 1 in Bafia (Centre), 1 in Douala (Littoral) and 2 in Yabassi (Littoral).

- There are **13 traffickers behind bars this month:** 1 in East region, 3 in Centre, 3 in Littoral region and 6 in West region.
- 24 cases were followed up by the Legal Department this month.
- 21 cases were scheduled in court this month.
- **3 traffickers** were convicted this month.
- **Prosecutions**: There was a court ruling this month.
 - 28/11/2023: The Bafia Court of First Instance found the accused ANDELA EDZIGUI Maximin Junior, EMBOM Jean and ISSEKSEK Pascal guilty. ANDELA EDZIGUI Maximin Junior was sentenced to 2 months imprisonment and the two others to 6 months suspended sentences during 3 years. They were also sentenced to pay 100,000 FCFA each as fine and 1,758,500 FCFA jointly as damages.

They were arrested in Makenene on the 05/05/2023 for the illegal possession of 38 kg of pangolin scales.

- Giving a total of 11 media pieces produced in the French language and 4 in English making 73.3% in French and 26.7 in English.
- Interviewee: Wildaid Central Africa Director and LAGA Deputy Director
- Subjects focused on wildlife law enforcement including: The Ntui arrest of 2 traffickers with 91kg of pangolin scales, the arrest of a city council worker with a drill and an interview of the Deputy Director on wildlife crime.


